I am directed to refer to your letters dated 17.11.2023, 30.11.2023, 05.12.2023 & 14.12.2023 and to state that the list of newly elected office bearers along with their terms of office in their respective post has been taken on record, as per the provisions of the party constitution.

The above tenure and election of the officer bearer are subject to the condition that the political party do not re-elect the whole executive body or any member of the Office Bearer and there should neither be any internal dispute nor any case should be filed by anyone for the above mentioned post.

Further, it is also informed that from the list of authorized office bearers if anyone applies for seeking common symbol in any General Election to Legislative Assembly/House of People, his application may be considered with effect from the date mentioned on this letter, provided they fulfill the criteria required for allotment of Common Symbol under Para 10B of Symbol Order, 1968, and not from the date of meeting in which election for office bearers have been held.

2) Further, it is informed that Commission does not approve the flag of political Parties and if the party has a flag, it shall be the own responsibility of the party to ensure that the flag does not violate the provisions of the Emblems and names (Prevention of Impretuous use) Act, 1950 on the flag code of India or any other relevant law related to the subject and the its flag doesn't imitate in any manner the flag of any other political party.

3) Further, it is also informed that "Naba Bharata Nirmana Seva Party" is a registered unrecognized political party and the benefits given to registered un-recognized political parties is available in one page (copy enclosed).

**Benefits that accrue to a Registered Political Party:-**

- a) The following are the benefits available to registered un-recognized political parties :
- (i) The candidates set up by a political party registered with the Election Commission of India will get preference in the matter of allotment of free symbols vis-à-vis independent candidates.
- (ii) Registered political parties, in course of time, can get recognition as 'State Party' or National Party' subject to the fulfillment of the conditions prescribed by the Commission in the Election Symbols (Reservation and Allotment) Order, 1968, as amended from time to time.
- (iii) As per Section 77 of the Representation of the People Act, 1951, the registered political parties are entitled to nominate upto twenty leaders for propagating the programme of the Party in connection with an election. The travel expenses of such duly nominated leaders will not count towards the election expenditure of candidates of that Party when these leaders visit various constituencies. Names of the leaders for this purpose have to be communicated to the Commission and the Chief Electoral Officer of the State concerned within the period of seven days from the date of notification of the election. A recognized party can nominate upto forty leaders in this regard [Pl refer to Explanations (1) and (2) under Section 77 of RP Act, 1951].
- (iv) As per para 10B of the Election Symbol (Reservation & Allotment) Order, 1968, registered un-recognised political parties can seek allotment of a common symbol for its candidates in a general election to the Legislative Assembly or House of the people, as per the conditions specified in the said paragraph.
- (v) As per the provisions of Section 29B of the Representation of the People Act, 1951, the political parties can receive contribution (donation) from individuals or Companies (other than a government company).
- (vi) In the ballot paper, names of candidates of political parties will appear above the names of independent candidates.
