**Sub: Bye-Election to 13-Kandhamal Parliamentary Constituency, 2014 -
Special C.L. to Government Servants for enabling them to Vote.**

Madam/Sir,

In order to enable the Government employees who are needed to exercise their franchise at a place away from their headquarters, special casual leave for a maximum period of two days was allowed during previous elections. It has been decided that similar facilities will also be extended during the ensuing Bye-Election to 13-Kandhamal Parliamentary Constituency, 2014 to be held on 15.10.2014 (Wednesday). A copy of the schedule of election indicating the day of poll in the above Parliamentary Constituency is enclosed.

2. The day of poll is declared a Public Holiday in the Constituency area. Government employees who are stationed at a place away from their Polling Stations have to travel for casting their votes. Such employees who are to vote on 15.10.2014 (Wednesday) may be allowed Special Casual Leave for a period of two days (the day preceding the poll and the succeeding the poll), if required, in order to enable them to travel and vote at their Polling Stations.

3. Employees who desire to exercise their franchise at a Polling Station away from the Headquarters and do not enjoy a holiday on the day of poll because their offices being located in the Constituency which does not go to poll on that day, will be granted Special Casual Leave for one more day on the day of poll.

4. The leave to be granted may be treated as Special Casual Leave which will not be taken into account in reckoning the total period of casual leave and special casual leave of 15 days usually admissible to a Government servant in the Calendar Year.

5. The written application by the staff will be sufficient to presume their enrolment in the particular Constituency.

6. The Head of Offices granting the Special Casual Leave will determine as to whether the employees can be spared and granted the leave without detriment to official work. Ordinarily, the staff should not be inconvenienced in exercise of their franchise and the expression "without detriment to official work" should be liberally interpreted.

7. The Sub-Ordinate offices may be informed accordingly.



NOTIFICATION

No. 100/OR-HP/1/2014: WHEREAS, the seat of Shri Hemendra Chandra Singh in the House of the People, elected from 13-Kandhamal Parliamentary Constituency in the State of Odisha, has become vacant on 5th September, 2014 by reason of his death; and

2. WHEREAS, a bye-election is required to be held for the purpose of filling the vacancy so caused;

3. NOW, THEREFORE, in pursuance of sub-section (I) of Section 149 and Sections 30 and 56 of the Representation of the People Act, 1951 (43 of 1951), the Election Commission of India hereby:—

(A) calls upon the said 13-Kandhamal Parliamentary Constituency in the State of Odisha, to elect, before the 22nd October, 2014 (Wednesday) and in accordance with the provisions of

the said Act and of the rules and orders made thereunder, a person for the purpose of filling the said vacancy in the House of the People.

(B) appoints, with respect to the said election:—

- (a) the **26th September, 2014 (Friday)**, as the last date for making nominations;
- (b) the **27th September, 2014 (Saturday)**, as the date for the scrutiny of nominations;
- (c) the **29th September, 2014 (Monday)**, as the last date for withdrawal of candidatures;
- (d) the **15th October, 2014 (Wednesday)**, as the date on which a poll shall, if necessary be taken;
- (e) the **22nd October, 2014 (Wednesday)**, as the date before which the election shall be completed; and

(C) fixes the hours from 7-00 AM to 4-00 PM , as the hours during which the poll shall. If necessary, be taken on the date specified above for the election.
