### NOTIFICATION

No.100/ECI/NOTI/TER/ES-II/OR-LA/2/2020: WHEREAS, the seat of Shri Bishnu Charan Das in the Legislative Assembly of the State of Odisha, elected from **102-Tirtol (SC) Assembly Constituency** has fallen vacant on 6<sup>th</sup> July, 2020 by reason of his death; and
