- The rates of compensation/ hire charges for other types of vehicles as contained in Home (Elections) Department Notification No.3053/Elec. dated 4th March, 2014 remains unchanged.
- When a vehicle is detained for more than 12 hours in any day this will be treated as on duty for a full day and vehicles detained for less than 12 hours will be treated as on duty for a half day and compensation will be paid accordingly.
- The fuel and lubricant consumed by the requisitioned vehicles while on election duty will be provided by the Government.
