NOTIFICATION

No. 308/ECI/NOT/TERR/ES-II/OR-LA/2019: WHEREAS, for the purpose of holding of General Election to the Legislative Assembly of Odisha-2019, the Governor of Odisha had, by Notification issued under Section 15 of the Representation of People Act, 1951 (43 of 1951) and published in an Extraordinary issue of the State Gazette dated 2nd April, 2019, called upon all the Assembly Constituencies including the 96-Patkura Assembly Constituency in the State of Odisha to elect member to the said Legislative Assembly; and

Whereas, due to death of one contesting candidate, namely, Shri Bed Prakash Agarwalla from 96-Patkura Assembly Constituency set up by Biju Janata Dal, a recognized State Party, the Returning Officer for the said Assembly Constituency adjourned the poll in accordance with the provisions of Section 52(1)(C) of the Representation of the People Act, 1951; and

Whereas, the election was held as scheduled from all the ACs, except 96-Patkura Assembly Constituency, and the results of the elections in all Assembly Constituencies in the said General Election, except aforesaid Assembly Constituency, was declared by the Returning Officers concerned and the Commission notified the names of members elected from those constituencies, along with their party affiliation, if any, in the SCHEDULE to the notification vide its notification No.308/OR-LA/2019 dated 25th May,2019; and

Whereas, the Commission, vide its notification No. 492/ECI/NOT/TERR/ES-II/OR-LA/2019 dated 5th July,2019, notified the schedule of the further stages of the election from the said 96-Patkura AC; and

Whereas, the poll was taken as scheduled and the results of the election from the said constituency has now been declared by the Returning Officer:

Now, therefore, in pursuance of Section 73 of the Representation of People Act, 1951 the Commission, hereby notifies the name of member elected from the said constituency, referred to above, along with the party affiliation, as under:
