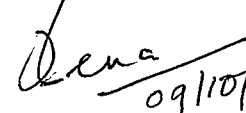
Sir,

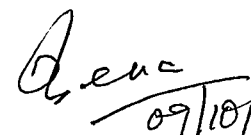

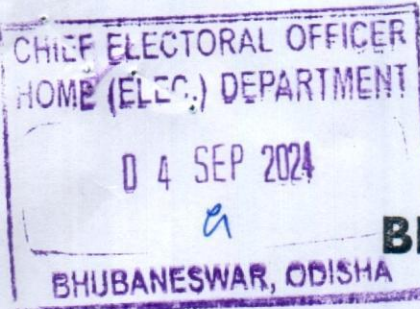

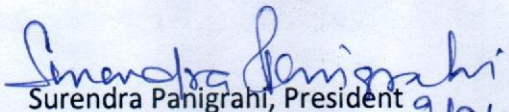
